- i) We will have in place a proper and welldocumented complaints handling process and provide clear redress options should customers decide to further escalate their complaints;
- We will ensure that our staff are properly trained to handle and resolve complaints in an effective and timely manner;
- iii) We will monitor and evaluate the nature and trend of complaints received through effective root cause analysis and thereafter take adequate measures to rectify weaknesses identified.

- We commit to ensure that vulnerable consumers are treated fairly and equitably by our staff
- We will ensure that we assess the needs of vulnerable consumers in our customer base and target market and implement appropriate policies to meet these needs;
